On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- The institution has acquired the land for setting up the teacher education institution.
- The institution has constructed the building for conducting the course on the above mentioned land.
- c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
- d. The institution has selected the <u>Principal and Seven</u> lecturers for the said course and the list of faculty members has been approved by the affiliating University.

Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Sowkhya College of Education, N.H.17, Bhatkal-581320, Uttara Kannada District, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students subject to tuitillment of the following.

The institution will ensure that Principal and Seven faculty members duly approved by affiliating University are in position for an intake of students before commencement of the course and a report effect shall be sent to the Southern Regional Committee in any and in any case not later than one month from the dot energement of the course.

- The institution shall submit to the Regional Committee a Performance As Report at the end of each academic year along with a copy of the approval affiliating University to the appointment of faculty members, and the states annual accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the proof the NCTE Act, Rules, Regulations and Orders made or issued theround Regional Committee may withdraw the recognition under the Providence of the NCTE Act, 1993.
